## The Best Little Work Incentives in Maryland: Employed Individuals with Disabilities (EID) Program and the Earned Income Tax Credit (EITC)

Discover these powerful work incentives that can encourage your customers to work, and reward them when they do:

- 1) The Employed Individuals with Disabilities (EID) Program provides Medical Assistance for Marylanders with disabilities who work for pay and meet a few other conditions. Medical Assistance provides excellent coverage if you are uninsured, and can supplement other insurance (including Medicare), saving up to thousands of dollars a year. Learn about changes to the program that enable many Medicaid Waiver participants to take advantage of EID without losing their Medicaid Waiver services.
- 2) The Earned Income Tax Credit (EITC) provides a credit to people who work and have somewhat limited incomes. The EITC can not only reduce or eliminate a person's income taxes owed, but can in many cases provide a refund.
